
BOBBY LEE BRADLEY JR.

Bobby Lee Bradley Jr. was born on November 17, 1960, in Valdosta, Georgia, to Clara Irvin Nelson and Bobby L. Bradley Sr.

His early childhood church was Mt. Zion African Methodist Episcopal Church in Daytona Beach, Florida, and in later years he became a member of Stewart Memorial United Methodist Church in the same city.

In 2003 he was certified for the ordained ministry, and in 2004 he was licensed as a full-time local pastor. At the time of his death, Pastor Bradley was serving at Mt. Pleasant in Gainesville.



Bobby married Betty Toomer on October 19, 2002, in Miami, Florida.

His children are Marishia Bradley, Brishaun Bradley, Lamiya Bradley, Donnie Jackson, and Nikka Lester.

Bobby died on June 9, 2007, while attending the Florida Conference in Lakeland. Funeral services were held on June 15, 2007, at Mount Carmel Baptist Church in Gainesville, Florida. A memorial service was held on June 16, 2007, at Gertrude Hotchkiss Heyn Memorial Chapel on the campus of Bethune-Cookman University in Daytona Beach. The service of committal and interment took place in Greenwood Cemetery in Daytona Beach. Officiating clergy were the Reverend Dr. Geraldine McClellan and the Reverend Dr. Kevin James Sr.

HAROLD BAIN BUSEY

On Sonrise Orchard in Berkley County, West Virginia, a mother held her tiny child and prayed, "Lord, please, if it is your will, cool the fevered brow and with your loving touch heal my baby and I will raise him up in Your Honor and he will follow You all of his days."

That tiny baby was Harold Bain Busey. He was born on May 27, 1930, to George and Mary Grace Busey, the youngest of seven children. Harold spent his childhood in the apple orchard country of Berkley County, West Virginia. He always referred to himself as "just a little country boy." Harold joined the United States Air Force at the age of seventeen and served his country from 1948 to 1954. Following his service in the air force Harold returned to West Virginia and enrolled in Shepherd College in Shepherdstown, from which he received degrees in biology and education. He earned his master's degree in administrative education from the University of West Virginia at Morgantown and then taught biology at Harpers Ferry High School.

In 1960 Harold moved to Melbourne, Florida, where he taught biology, served as curriculum coordinator, and was an elementary school principal at Spessard Holland



Elementary School. Harold was a member of First United Methodist Church in Melbourne, where he belonged to the Pairs and Spares Sunday School Class and United Methodist Men.

With the encouragement of the Reverend J.A. Padgett, Harold entered Candler School of Theology, Emory University, at the age of forty. He received a master of divinity degree and completed the coursework for a doctorate in theology. He was admitted as a probationary member of the Florida Conference and ordained deacon in 1971 and was ordained elder in full connection in 1975. He served churches throughout Florida: associate, First, Lakeland, 1973-74; Marco Island, 1974-79; Memorial, Fernandina Beach, 1979-82; St. Luke's, St. Petersburg, 1982-86; Trinity, Lighthouse Point, 1986-88; Zellwood, 1988-93; Union Street, Clearwater, 1993-96; and First, Ft. Pierce, 1996-99. He retired in 1999.

Reverend Busey served on the Florida Conference Board of Ordained Ministry and the Board of the Florida United Methodist Credit Union. During his retirement, he was interim pastor of four churches—McCall's Chapel, Flagler Beach, Seville, and Pierson—and then served as congregational care pastor at Palm Coast. In his retirement he spent many of his days writing a book as a gift to his grandchildren. The book, containing memories of his childhood in West Virginia, was titled *Just a Little Country Boy*.

After a long battle with cancer, on Sunday morning December 9, 2007, a wonderful, marvelous, extraordinary miracle took place. Harold, that "little country boy," was finally given his opportunity to walk through Heaven's Gate. He is now in the presence of our Lord Jesus Christ and celebrating a tremendous reunion with friends and family who have gone on before.

Harold's life was blessed by his family: his wife and love of his life, Krista; daughter and son-in-law, Karen and Rick Bailey; daughter and son-in-law, Melissa and Drew Kaminski; daughter and son-in-law, Jennifer and Jim Meyer; son and daughter-in-law, Jack and Becky Robertson; son, Jeremy Robertson; and five grandchildren, Kyle, Connor, Garrett, Delaney, and Christopher.

A memorial service was conducted on December 16, 2007, by the Reverend Peggy Wilkins and Chaplain Harry Gilman at Palm Coast United Methodist Church in Palm Coast, Florida.

Harold will be remembered for his love for the Lord, his service to the church, his unconditional love, and his quiet, gentle nature.

ROBERT ELLSWORTH CLARK



Robert Ellsworth Clark was born in Brooklyn, New York, on November 7, 1930, to Edward V. Clark Jr. and Emily May Pritchett Clark.

He married Grace Olive Eliades on August 29, 1953. They had four children: David Scott Clark, born on June 13, 1954; Dawn Susan Clark Sovinsky, born on October 2, 1957; Darryl Stephen Clark, born on June 14, 1959; and Dana Star Clark Kinsey, born on July 22, 1961.

He graduated from Eastern Nazarene College in 1957 with a bachelor of science degree in music, philosophy, and theology and from Florida Atlantic University in 1969 with a master of education in curriculum and instruction. He received a master of divinity degree in Christian education from Candler School of Theology at Emory University in 1972.

Bob was admitted as a probationary member of the Florida Conference and ordained deacon in 1971. He was ordained elder and received into full connection in 1978. He served the following appointments: associate, Calvary, Lake Worth, 1972-73; Howe Memorial, Crescent City, 1973-75; associate, Trinity, Tallahassee, 1975-76; Lake Jackson, Tallahassee, 1976-77; Hallandale, 1977-79; and Green Cove Springs, February- June, 1979. He took a leave of

absence in 1979 and then served Inman Memorial, Jacksonville, January-June, 1981. He took another leave of absence in 1981 and was granted honorable location in 1984.

In 1982 Bob was called to serve in prison ministry. At Union Correctional Institute in Raiford, Florida, he led the Tuesday night Bible study and the chapel singing and developed a remedial reading program called "Learn to Read Using the Bible." Both Grace and Bob served as instructors every Tuesday afternoon. He also conducted the chapel choir and taught weekly Bible studies at the Lawtey Correctional Institute.

Bob served on fifty-eight teams of Kairos Prison Ministry, Cursillo, and Emmaus in both Florida and Georgia. He served on his fifty-eighth team at the Putnam Correctional Institution just two weeks before his death.

On December 7, 2007, he died of heart failure, quietly, peacefully, and alone, seated on his couch in the living room.

A memorial service was held on December 14, 2007, at Mandarin United Methodist Church in Jacksonville, Florida, with the Reverend David Brazelton and the Reverend Gene Strickland officiating. Others speakers were from the Kairos Prison Ministry team, with whom Bob had served for twenty-five years. The service concluded in the Kairos tradition with the a capella singing of "Surely the Presence of the Lord Is in This Place" and "The Lord's Prayer."

Survivors are his wife, Grace Clark; his children, David S. Clark and wife Aurelia; Dawn Susan Sovinsky and husband Terry; Darryl S. Clark and wife Sherrie; and Dana S. Kinsey and husband Bob; and grandchildren, Mathias and Rebekah Sovinsky; Charlotte and Martha Ashley Kinsey; Devlin, Tristan, and Liam Kidney; and Micah Clark.

Bob was an avid fisherman and loved boating; almost every Saturday was set aside for boating activities. He lived on the St. Johns River in Jacksonville and the Satilla River in Woodbine, Georgia, for twenty-four years, with a boat at the end of the dock.

WILLIAM HOYT COVERT

William Hoyt Covert was born in Middleport, Ohio, on November 9, 1949, to William Merrill and Rose Bolin Covert.

While rearing four children, William studied for the ministry and was licensed to preach in 1951 in Ohio; he was ordained a local deacon in 1955 and a local elder in 1957. From 1952 until 1966 he served Albany, Carroll, and Convoy as well as several other small churches in Ohio. After coming to Florida in 1966, he served Safety Harbor, 1966-67, and Safety Harbor/Sylvan Abbey, 1967-70, before being admitted as an associate member of the Florida Conference in 1970. He then served Orange Heights (now Good Shepherd), Lakeland, 1970-75; Highland City, 1975-76; and Branscomb Memorial, Tampa, 1976-80.

After retirement to Hudson in 1980 the Reverend Mr. Covert continued holding services at nursing homes, visiting hospital patients and shut-ins, conducting weddings and funerals, and counseling. He assisted pastors at several churches through the years and was named pastor emeritus at Faith, Hudson.

Gifted in carpentry, he oversaw the building of Good Shepherd in Lakeland and Faith in Hudson. In retirement he built an addition to his house, as well as porches, decks, and deck furniture. He also enjoyed helping others with their carpentry. He had many decorating ideas, made decorative plaques, and upholstered furniture.

Paul J. Erb was born to Jacob and Erma Baker Erb on September 22, 1924, in McClure, Pennsylvania.

Paul received an audible call from God, which changed his life forever. His devotion to God was a true inspiration to everyone who knew him. "For God loved the world so much that he gave his only Son so that anyone who believes in him shall not perish but have eternal life." (John 3:16) Paul loved this scripture and read it beautifully the last day of his life.

He married Betty Jane Peck during an Easter sunrise service on April 21, 1946.

After graduating from high school, Paul entered the United States Marine Corps. Corporal Erb served in the Pacific with Marine Crops Squadron VMB-433 during World War II. After the war he graduated from Asbury College and Asbury Theological Seminary. He was licensed to preach by the Evangelical United Brethren in 1955 and was ordained elder and received into full connection in the Central Pennsylvania Conference, EUB, in 1958.

THEODORE MERRILL HAGGARD



Dr. Haggard was admitted on trial in the North Georgia Conference in 1956, ordained deacon in 1958, and ordained elder and received into full connection in 1959. He served as student pastor at Wesley Chapel, Decatur, 1956-58, and Salem, Covington, 1958-60; full-time pastor at Silvertown, Thomaston, 1960-62; student pastor at Bethesda, Lawrenceville, 1962-65; full-time pastor at First, Palmetto, 1965-66; and dean of instruction at Reinhardt College, Waleska, Georgia, 1966-72.

Upon transferring to the Western North Carolina Conference, Dr. Haggard served as director of development at Pfeiffer University in Misenheimer, 1972-74, and as dean of students at Brevard College in Brevard, 1974-77. In 1977 he became assistant to the president and director of the library at Florida Southern College in Lakeland, where he served until his retirement in 1991. He transferred to the Florida Conference in 1978. In addition to his work as an administrator he enjoyed teaching philosophy and Old and New Testament. The Haggards moved to Charlotte, North Carolina, in 2006.


Dr. Haggard died on January 9, 2008, in Charlotte, North Carolina. A memorial service was held on January 12, 2008, at Providence United Methodist Church in Charlotte, with Dr. Kenneth H. Carter, Jr., officiating. Interment, with the Reverend Jim Wofford officiating, was in the Alexandria, Kentucky, Cemetery.

CHARLES PURYEAR HAMILTON



Charles Puryear Hamilton was born on May 15, 1926, in Subligna, Georgia, to Joseph and Drucilla Hamilton. He was named for his paternal grandfather and grew up on his grandfather's farm. During a church revival the summer he was thirteen, he received the call to preach. In 1943 he graduated from the Subligna School as salutatorian of his senior class. From 1943 to 1945, he attended Young Harris College in Young Harris, Georgia, receiving a license to preach at the Pleasant Hill Methodist Church the summer between his freshman and sophomore years.

From 1945 to 1947, he attended Florida Southern College, majoring in Spanish and religion. While there, he served the Eaton Park and Cork Methodist churches as a student pastor. He finished his course work the summer after the 1945-46 school term. At that time the college held only one graduation a year, so he waited until the next May to receive his diploma.

While at Florida Southern he met and married Nancy Thomson, and they celebrated sixty-one years of marriage in August of 2007. Daughters were added to this parsonage family

in 1954, 1960, and 1962.

They thought they'd go straight from Florida Southern to seminary at Emory, but Charles was asked to stay in Florida, for a year, to serve Carlson Memorial in LaBelle. From 1948 to 1951 he attended Candler School of Theology at Emory University, receiving a master of divinity degree in 1951. While at Candler, he served the Methodist churches at Lone Oak, Moreland, East Newnan, and Luthersville, known as the Moreland Charge. He was admitted into the Florida Conference on trial in 1949; he was ordained a deacon in 1950 and an elder in full connection in 1951, upon graduation from Emory.

After graduation, Charles and Nancy returned to LaBelle, where he served until 1953. In 1952 he started the church at Immokalee, serving both churches until 1953. His other appointments were Immokalee/Jerome, 1953-57; Spring Glen, Jacksonville, 1957-63; College Heights, Lakeland, 1963-68; superintendent, Sarasota District, 1968-74; First, Pompano Beach, 1974-80; superintendent, St. Petersburg District, 1980-86; and Southside, Jacksonville, 1986-91. He retired in 1991, having served the Florida Annual Conference for forty-two years.

In addition to his duties as pastor, Charles was one of the founders of the Florida United Methodist Foundation and a member of the original board of directors, serving the foundation throughout the lifetime of Dr. Robert C. Holmes, foundation director. During the 1970s, he served as a trustee at Florida Southern College. He received an honorary doctor of divinity degree from Florida Southern in 1973 and participated in the graduation ceremonies of his daughter Mary in 1975.

After retirement Charles and Nancy spent the winters in Lakeland, Florida, and the summers on the family farm in Subligna, Georgia. On December 12, 2007, God called Charles home, after a lengthy illness. Memorial services were held on December 17, 2007, at College Heights United Methodist Church in Lakeland, with a family burial later that day in Oak Hill Cemetery in Lakeland. Long-time friends, the Reverend Gene Zimmerman and the Reverend Ray Harrison, officiated, along with his pastor, the Reverend Daphne Johnson.

He is survived by his wife, Nancy; their three daughters and sons-in-law, Mary and Steve Williams of Cumming, Georgia; Becky and Mike Vickers of Tallahassee; Florida; and Polly and Joel Beebe of Orlando, Florida; grandchildren, Brandon, Jennifer, and Ashley; sisters, Linda Keziah and JoAnn English; and brother, Bobby Hamilton.



BURNELL SHELTON JORDAN



Lindsey Price Pherigo was born to Ezekiel and Dorothy Price Pherigo on December 29, 1920, in Miami, Florida.

Lindsey received a bachelor's degree from the University of Florida in 1942, an S.T.B. from Boston University School of Theology in 1945, and a Ph.D. from Boston University in 1951. He received a post-doctoral faculty fellowship from the Ford Foundation for study at Hebrew Union College in Cincinnati, Ohio, 1953-54. Received on trial in the Florida Conference and ordained deacon in 1948, he was ordained elder in 1950.

Following an academic rather than a pastoral ministry path, he served as instructor in religion at Syracuse University, 1949-51; professor of Bible at Scarritt College, 1951-57; professor of Christian life and thought and academic dean at Scarritt 1957-59; lecturer in New

Testament at Vanderbilt University Divinity School, 1954-59; and professor of New Testament and early church history at Saint Paul School of Theology, 1959-85. He also served as Biblical and theological consultant at the Village Presbyterian Church in Prairie Village, Kansas, from 1979 until his death.

Lindsey wrote a commentary on the Gospel of Mark for the *One-Volume Interpreter's Commentary on the Bible* and articles for the *Journal of Biblical Literature* and the *Journal of Bible and Religion* as well for Methodist publications such as *Motive, Religion in Life, The Adult Teacher,* and *The International Lesson Annual*. He also wrote the 1983 study book for United Methodist Women, *The Great Physician*.

Upon his retirement in 1985 the students of Saint Paul honored him with the establishment of the Lindsey P. Pherigo Chair in New Testament and Early Church History. He spent the next twenty-two years as guest speaker and teacher.

He was a member of the American Society of Church History and the Society of Biblical Literature and Exegesis. He traveled and studied abroad. Teaching was his first love, and classical music his second love.


STACY SELPH



HENRY MELTON WARE

Henry Melton Ware was born in Camak, Georgia, on June 20, 1915, to Robert and Blanch Kitchens Ware. He was active in other conference agencies, the Florida Council of Churches, and the communities in which he served. MARY CHATTIE CALHOUN



Mary Chattie Calhoun was born on December 19, 1915, in Perry, Florida, to the late Reverend Eugene C. Calhoun Sr. and Gussie Barnes Calhoun.

She graduated from Columbia High School in Lake City, Florida. She received a bachelor's degree in education from Florida Southern College, Lakeland, Florida, in 1939. She completed graduate work at Scarritt College, Nashville, Tennessee, and Garrett Biblical Institute in Chicago and received a master's degree in religious education from Boston University in 1952.

After teaching elementary school in Lake City, Florida, for four years, she was certified as a director of Christian education and accepted the position of director of children's work for the Florida Conference in 1941. She became an early childhood specialist in the Children's Division of the General Board of Education of the Methodist Church in Nashville, Tennessee, in 1954. She was consecrated a diaconal minister in 1977.

During her tenure in Nashville she traveled the country conducting workshops, leading seminars and lab schools, serving as a resource for annual conferences and local churches, and writing books and training materials for teachers of young children. She was instrumental in

developing two significant national gatherings that focused on training children's teachers and leaders in the development of new methods of relating to children in the church and community.

Despite her petite stature, Mary was a spiritual and educational giant. She was recognized for distinguished service by a number of ecclesiastical organizations, and in 1968 Florida Southern College recognized her as a distinguished alumna with an Outstanding Service to Mankind award. She was a person of keen mind and Christian integrity.

Following retirement to Clyde, North Carolina, in 1978, Mary was active in the First United Methodist Church of Waynesville, especially in the music ministry as a member of the handbell choir. After moving to the Givens Estates retirement center in Asheville, North Carolina, in 1997, she served two terms as president of the Residents Council and as a member of the Board of Directors.

Mary was an exceptional photographer. She was also a skilled seamstress, tailoring and making most of her clothes, and she was gifted at needlepoint, working on liturgical pieces for the chancel of the First United Methodist Church in Waynesville not too many years before that sanctuary burned. She was described by her college math professor as a "natural mathematician" and one of the most brilliant students he had ever had. He was disappointed that she was determined to teach elementary school. Obviously God had another plan for her life.

Mary died peacefully on May 5, 2007, at Givens Estates after a period of declining health. A memorial service was held at the Pulliam Chapel of Givens Estates on Friday, May 11, 2007, with the Rev. Joe Fulk Jr. and the Rev. Ashley M. Calhoun officiating. Her ashes are interred in the family cemetery plot in Woodlawn Cemetery in Perry, Florida.

She was preceded in death by her parents; her brother, Ashley Barnes Calhoun Sr.; and her nephews, Eugene C. Calhoun III and Ashley B. Calhoun Jr. Survivors include her sister, Rabun Calhoun Chappell of Jacksonville, Florida; her brother, Dr. E. Clayton Calhoun Jr. of Givens Estates; one niece; five nephews; and several grandnieces and nephews.

Joanne Trautmann Banks was born in Stillwater, Minnesota.

She received a bachelor's degree from the University of Wisconsin-River Falls and a master's degree and an honorary doctorate from Purdue University. She taught English, humanities, and medicine at Drexel University, Pennsylvania State University, the University of Virginia, and Eckerd College in St. Petersburg, Florida.

Well-known in literary circles, Mrs. Banks was recognized as a leading scholar on author Virginia Woolf, having coedited with Nigel Nicholson the six-volume *Letters of Virginia Woolf*.

A pioneer in interdisciplinary studies, interested especially in the connections between the humanities and medicine, she was a founding editor of the Johns Hopkins journal *Literature and Medicine*. She also wrote two books in the field, *Healing Arts in Dialogue: Medicine and Literature* and *Literature and Medicine: An Annotated Bibliography*.

She was a fellow of the Institute for Arts and Humanities in Pennsylvania and received a lifetime achievement award from the American Association for the Study of Bioethics and Humanities.

She created the Banks Center for Interdisciplinary Inquiry at the University of Wisconsin-River Falls, and in honor of her late husband she established the Samuel A. Banks Study Area in the Peter H. Armacost Library at Eckerd College.

She was described as an intelligent and generous woman, devoted to her family and wide circle of friends.

Mrs. Banks died at home in St. Petersburg Beach on May 5, 2007. Funeral services were held in the Wireman Chapel at Eckerd College on May 25, 2007, with burial in Oak Hill Cemetery in Lakeland the following day.

She was pre-deceased by her husband, Dr. Samuel A. Banks Jr. She is survived by a son, Piers Samuel Alston Banks, St. Petersburg, Florida; a stepson, Andrew Banks, Hamilton, Bermuda; a stepdaughter, Lisa Banks, Raleigh, North Carolina; a brother, P. Thomas Belfiori, Sauk Rapids, Minnesota; and a sister, Patricia Belfiori, River Falls, Wisconsin.

The youngest of five children of Forrest and Effie Wells Mosher, Ivaloo Mae Mosher Black was born on August 27, 1916, in Essex, Ohio. She had two brothers and two sisters, one of whom died in infancy. Her name came from a friend of her mother who was "a very nice lady." Ivaloo Mae was also very nice—she was well liked and was the proverbial entertainer in her community growing up.

Ivaloo was usually first in school rankings and played piano well. She loved reading and memorized works of literature, quoting them to her grandchildren many years later.

In early junior high school, she met Richard A. Black. Over the next eight years they each dated a few other people occasionally but were pretty much a couple most of that time.

At twenty, in 1936, she married Richard and they moved to Jacksonville, Florida, where Ronald was born. Richard had started college and served a two-point student pastorate before their trek to Florida. After a year, they returned to Ohio, where Richard finished college and seminary. Ivaloo typed his papers and should have received degrees too; nevertheless, she felt her call as the wife of a minister and worked well and vigorously by Richard's side.

Before the end of his schooling, Janice and Cliff arrived, and Richard served student pastorates nine more years. Ivaloo was a gracious parsonage hostess to visiting missionaries, bishops, and other dignitaries as well as to local parishioners and friends. As a talented church school teacher, she served both youth and adults. She held district and conference offices in the women's groups and served as dean and instructor in conference schools of mission.

Ivaloo, like the mother in "The Christmas Story," could often predict what the consequences would be if the preacher's kids did this or that or the other. This happened so often that we thought she might be a witch, when actually she and Dad just had a lot of wisdom. Mom's slogan to us as children growing up was "Let go and let God." Their youngest grandson uses that often to remind his mother Who is in charge. Ron, Cliff, and I grew up knowing our faith in Christ was ours, not just our father's and/or mother's. They taught us to pray, and their granddaughter challenged those attending Ivaloo's memorial service to pick up the gauntlet from this prayer warrior. Ivaloo never ceased to pray for others.

Mom was anxious to be with Dad—together again and forever. Though we were not ready, the family is grateful she was able to live alone after Dad's death in 1989. Over the last year and a half, Ivaloo thoroughly enjoyed the time she shared with her two great-granddaughters, Eva Grace Bingham and Emma Kathleen Smithson. Mom had a special relationship with each of her grandchildren: Geoff, Chris, Jon, Heather, Maria, Shawn, Maricela, Jose, and Carlos. Several of them spent time with her during the last six weeks of her life. Mom laughed and shared special times with each of them. Most of us didn't share the goodbyes we would have chosen, but we are blessed for having shared Mom's life.
